Enrollment Information

Extended Care

The hours for before care are 7:30am-8:30am and after care 3:00pm-6:00pm daily. This charge will be a flat fee. St. Martin's School is no longer offering hourly rates for this care.

Application/Registration Fee

A \$75 non-refundable fee is due with application. A \$350 non-refundable deposit is due with registration. This will be credited towards the first month's tuition.

Forms

The following forms will need to be on file in order for your child to be enrolled at and attend St. Martin's School: Universal Health Record, Immunization Records including immunization for flu, Emergency Medical form, Authorized Pick-up Persons form, Photograph Consent form, Authorization of Outside Activities form and Information to Parents form. Failure to return these forms before the first day of school will result in your child being unable to attend.

Tuition Plans

Plan A: Single Installment – Due July 31, 2025, offers a 2.5% discount.

Plan B: Tuition will be invoiced monthly

In accepting this agreement, the parent/guardian accepts responsibility for the tuition stated in the tuition schedule. The school reserves the right to cancel a student's enrollment if payment is not made by the agreed upon due dates. Late payments are subject to a late charge of 1.5% per month.

Fees

A charge of \$50 will be applied to all balances for returned checks.

Charges for late pick-up: \$1.00/minute.

Refund Policy

In the case of a student withdrawn before August 1, 2025, any tuition already paid up to that date will be refunded.

In the case of a student being withdrawn on or after August 1, 2025, one month's tuition paid in advance of the date of withdrawal will not be refunded. All other tuition paid in advance will be refunded in full, with 30 days written notice.
